He further appealed to the general public to avoid accumulation of water in their surroundings and pay attention towards the hygiene in and around their homes and dwelling units.

Appreciating the efforts of JMC and Anti Malaria Wing of Jammu to launch such fogging drives for the safety and security of the people, the representatives of Association of Trikuta Nagar Welfare Society assured that they shall extend full cooperation and support to JMC in eradicating the menace of Dengue.

Later, Dr. Yadav chaired a meeting to review the status of grievances submitted through the Samadhan portal, instructing for prompt and effective resolution to ensure public convenience.

An awareness cum interaction programme was organized today by Veterinary section of JMC for work animal owners operating within JMC limits. The main motive of the programme was to aware the owners of Marriage buggies/ Horse cart/ horses/ Pony/ Mule/ Camel/ Donkey and other work animals regarding registration of their work animals in accordance with the Prevention of Cruelty to Draught and Pack Animal Rules, 1965 and J&K Municipal Corporation Act, 2000.

The stakeholders were appraised by Dr. Divya Sharma, VAS, JMC regarding importance of registration of work animals, their health & fitness status, duration of their working hours, capacity of load on animals and various animal welfare issues. The registration has been made hassle free by just submitting the fitness certificate of the animals and an affidavit in accordance with the Prevention of Cruelty to Animal Act, 1960 & Draught and Pack Animals Rules, 1965 by the owner. The owners were also made aware regarding the fines & penalties that could to be imposed on the defaulters.

Veterinary section of JMC is carrying out various drives within JMC limits to curtail the incidences of cruelty towards work animals as well as plying of these animals by their owners without obtaining proper licensing from Jammu Municipal Corporation.

JMC Commissioner visits dengue affected hotspot areas Leads Fogging Operations to Combat Dengue Outbreak

In a bid to intensify efforts to control the spread of dengue fever in Jammu, Commissioner, Jammu Municipal Corporation, Dr. Devansh Yadav (IAS), conducted an extensive tour of various wards under the jurisdiction of Jammu Municipal Corporation here today.

During the tour, the Commissioner visited wards number 63, 64, 65, 66, and 67, where the health and malaria team of JMC is actively engaged in fogging exercises to eradicate mosquito breeding sites and the main objective of the initiative is to prevent further cases of dengue fever by eliminating the mosquito population.

Emphasizing the importance of collective efforts in combating this public health concern, the Commissioner urged upon the residents to take proactive measures by disposing of collected water in and around their homes and dwelling units. Dr. Yadav directed the fogging team to expedite their operations, ensuring comprehensive coverage of all wards under jurisdiction of JMC as soon as possible, saying that the concerted effort would effectively control the dengue menace and safeguard public health.

Awareness programme on Environmental Management of Dairies/ Gaushalas and adoption of scientific dung disposal mechanisms

MVO section, JMC organized an Awareness programme on Environmental Management of Dairies/ Gaushalas and adoption of scientific dung disposal mechanisms at Gurdayal Dairy, Sanjay Nagar today on 27th September, 2024.

VAS, JMC, Dr. Divya Sharma and other officials of Veterinary section of JMC were present in the programme. The dairy owners & gaushala operators of Sanjay Nagar were invited in the programme for making them aware regarding management of dairies/ gaushalas & proper scientific dung disposal mechanisms viz. Installation of Biogas Plant, Vermi-compost unit, compost pits etc. to be adopted in their dairy units.

VAS, JMC Dr. Divya Sharma informed the local dairy farmers that Jammu Municipal Corporation has taken various initiatives regarding regulation of Dairies & Gaushalas operating within JMC limits in line with guidelines of JKPCC regarding Environmental Management of Dairies/ Gaushalas & FSSAI norms. Further, she informed that 82 no. of Dairy Units have already been registered with JMC and process is going on to register/regulate all the Dairy units/ Gaushalas operating within JMC limits. For mandatory registration, the dairy unit shall fulfill the said criteria as per the guidelines of JKPCC and FSSAI norms. These dairy units have installed Bio Gas Plants, Vermi Compost Units or adopted other techniques for scientific disposal of Dairy waste. She also highlighted the importance of such programs and events which will generate mass awareness for the stake holders to adopt and follow the guidelines issued by the regulatory agencies.

VAS, JMC Dr. Divya Sharma emphasized the importance of adoption of guidelines issued by JKPCC, JMC, FSSAI and in terms of directions of Hon'ble NGT so that every bit of dairy waste generated is properly recycled & utilized as manure and energy for the creation of waste to wealth.
